Preamble 1 In this study when we use the term cannabis, this includes **marijuana** (pot, weed), **hashish** (hash), **liquid extracts or concentrates** (cannabis oil), **solid extracts or concentrates** (shatter, budder, wax) or any other products made from the cannabis plant, but not synthetic cannabinoids (Spice, K2, Yucatan Fire, etc.).

READ AS NEEDED: Synthetic cannabinoids are manufactured in laboratories and are often sprayed onto dried plant material, mimicking certain effects of cannabis.

When we ask about cannabis use, this includes smoking it, vaping it, eating it in an edible product, or consuming it in any other way, whether for medical or non-medical purposes.
